WALK-IN-INTERVIEW FOR JUNIOR RESIDENTS (ON ADHOC BASIS) IN IGH, DWARKA

A walk in interview for engagement of Junior Residents on adhoc basis is scheduled to be held in IGH, Dwarka on **02.03.2026 (Monday)** with vacancy status as follows:-

All eligible candidates who are interested for the same are requested to report at **09:30 AM** on **02.03.2026 (Monday)** at 5th Floor, Seminar Room, B-6317, Indira Gandhi Hospital, Dwarka along with **duly filled performa** annexed with this notice, a set of self-attested copies of all certificates, marksheets and two passport size photographs. **Original certificates/documents are also required at the time of interview for verification. Candidate's reporting after 11:00 AM will not be considered for the interview.**

Only those candidates are required to report who fulfill the eligibility criteria as Residency Scheme and following criteria.

- 1. Qualification:** MBBS Degree from a NMC recognized university/Institute with internship completion certificate. Foreign Graduates must have cleared FMG Examination. **The candidate must not have done junior residency of one year from any recognized institute.**
- 2. Age Limit:** 30 years for General and 33 years for OBC candidates as on date of interview. Relaxations for - PwD as per rules.
- 3. Internship:** Must have completed one year rotatory internship after completion of MBBS/passed FMG examination on or after **01.03.2024**.
- 4. Registration:** Must have valid DMC Registration as on date of interview. Acknowledgement slip is mandatory, if applied.
- 5. Pay Scale:** The pay matrix of Level - 10 (Rs. 56100-177500), plus other usual allowance as admissible under the residency rules.
- 6. Tenure:** **The tenure of Junior Resident is purely on adhoc basis for a period of 89 days or till appointment on regular basis whichever is earlier.** Tenure will be extended after 89 days on the basis of satisfactory work & conduct report from the concerned HoD and written request from the doctor concerned. Any service rendered as Junior Resident earlier on adhoc/regular basis in any recognized government institution will be including in one year of Junior Residency.

GENERAL TERMS AND CONDITIONS

- Number of the vacancies may vary and filled in phases.
- OBC/EWS certificate issued from Govt. of NCT of Delhi shall only be accepted.**
- OBC candidate must have Non-Creamy Layer Certificate (Delhi only) for the current Financial Year (2025-2026).**
- Outside Delhi OBC candidates will be treated in the UR Category.**
- In case of OBC certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
- EWS candidate must have EWS (Delhi only) certificate for the current Financial Year (2025-2026).**

In case of OBC/EWS certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
08. Benefit of reservation will be granted only on the basis of caste certificate issued by the competent authority and production of original certificate.
09. Selection/appointment is purely on provisional basis, subject to verification of educational certificates and other related certificates/antecedents/DMC certificate and the candidate being found medically fit.
10. The service condition will be regulated as per the rules in the Residency Scheme, Ministry of Health & Family Welfare, Govt. of India of 1983.
11. Candidates if working on adhoc/regular basis must produce NOC from present employer.
12. NO TA/DA will be paid to the candidates appeared in the interview.
13. In case of number of applications are very high the interview may be continue on the next day.
14. Selected candidates shall be allowed to join within 07 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
15. Mode of selection will be through interview only.
16. In case of any inadvertent error detected at a later stage the same will be rectified as per rules.
17. Competent Authority reserves the right of any amendment or cancellation of the advertisement at any stage.
18. Competent Authority reserves right to decide in case of any dispute with regard to selection process.
19. In case of any Legal dispute, the jurisdiction of Court will be Delhi/New Delhi only.
20. No correspondence or personal inquiries shall be entertained.
21. Canvassing in any form is liable to the candidate being barred from selection.
22. Result will be declared on the website of Health & Family Welfare and Indira Gandhi Hospital.
23. In case of non availability of candidates in reserved category, candidates form other categories would be considered on adhoc basis.
24. In case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision circulated as per circular dated 10.06.2011 of Department of H&FW, GNCTD.
25. A panel of wait-listed candidates will be prepared for filling up the post of Junior Resident of vacancies arising in future. The panel shall remain valid for 06 months or till fresh selection process is carried out, whichever is earlier.

All interested candidates are advised to download the application form alongwith check list through the website of Health & Family Welfare as well as on the website of IGH for appearing in Interview as **no application form will be provided at the time of interview.**

Important:- If any declaration/information furnished by the candidate is found false/any material/fact suppressed willfully, the candidate appointment will be cancelled/terminated forthwith. The decision of the selection board/Medical Director of IGH, Dwarka regarding selection will be final and binding and no representation will be entertained in this regard.
