The posts are to be filled up on ad-hoc basis on first come first serve basis and strictly on merit basis.

ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENT:-

- 1. Qualification:-** MBBS with Post Graduate degree/Diploma from a Recognized University & registered with Delhi Medical Council (As per residency scheme).
- 2. Age Limit-** Age limit shall be maximum of 45 years as on the date of interview as per order no. F.DHF&W/Q015/57/2016-HR-Medical-Secy (H&FW) #11245062/1502/08 dated 26.11.2020 issued by H&FW department, GNCTD. The age relaxation for reserve category candidate is as per rule.
- 3. Pay Scale:** - Pay Matrix of Level-11(Rs.67700-208700/-) other admissible allowances per month.
- 4. Must have valid registration certificate with Delhi Medical Council.**
- 5. Appointment will be subject to verification of certificates of educational qualification/age/address proof/caste/DMC registration etc.**

6. Further in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation:-
- (I) In case of non availability of fresh candidates, the candidates who have completed 3 years of Senior Residency having Post Graduate qualification may also be allowed under relaxed norms to appear in the interview.
 - (II) Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
 - (III) Firstly, the list containing names of fresh candidates would be exhausted for appointment as Residents and the list of candidates appearing under relaxed norms would be used only after that.
 - (IV) Further, all Residents appointments from second list will be for one year only. It would not be renewable after one year.
7. There is no fee for appearing in the interview.
8. Reservation for person with disabilities candidates/Differently abled persons shall be as per rules of Govt. of India. Reservation for EWS category of General Category shall be as per rules.
9. No TA/DA shall be paid for appearing in the interview.
10. Hostel Accommodation will be provided for Senior Resident, if requested.
11. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing the interview.
12. Selected candidates shall be allowed to join immediately or maximum within 07 days of issue of the offer letter failing which the offer shall stand automatically cancelled. Hence, only those candidates who can join immediately need to apply.
